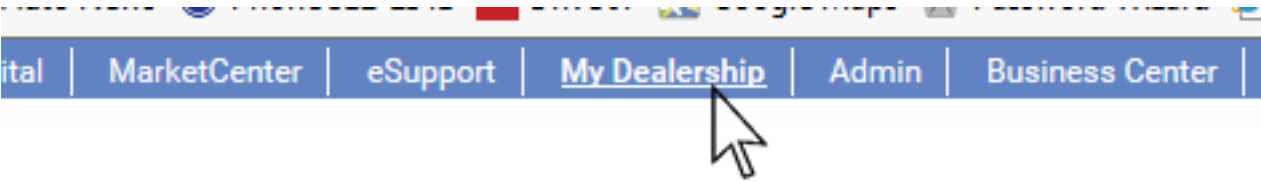
US dealers, effective January 2024, there will be an adjustment to subscription fees to maintain and enhance the quality of our services.

The new monthly subscription fees for wiTECH (DSSA) and Service & Parts Information (S&P Info) are detailed in the table below:

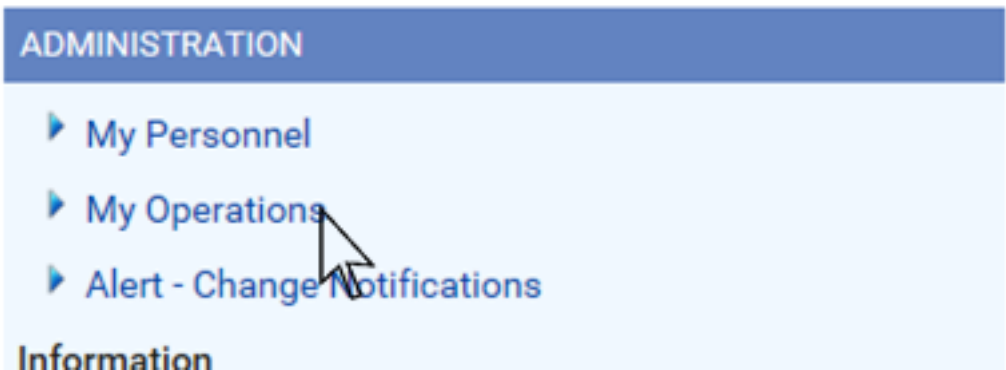

Effective February 2024, the wiTECH Infrastructure Maintenance fee (Billing Code 109 – wiTECH Diagnostic System) will be increased from the current \$75 per month to \$100 per month for maintaining and enhancing the quality of our services. This is the first increase for these fees in nearly 10 years.
